What work, outside your specialty, can you do? Our first contractor finds himself 'fenced out' on a job he can rightly do. A demolition

contractor helps us

'break down' the new 'asbestos licensing', and we must 'demolish' the ideas of a partnership hoping to maintain the 'status quo' in their current license...

Q: We currently have a "C-27" (Landscaping) license. We gave a bid to an insurance company for fencing but they said that we could not do the job since we are not a 'C-13' (fencing) contractor. Aren't we permitted to perform fence installation if it's part of a landscape?

A: The key to your question is "if it's part of a landscape". Board Rule 832.27 states that a landscaping contractor may undertake any single trade contract as long as the work is a part of "...landscape systems and facilities... which are designed to aesthetically, architecturally, horticulturally, or functionally improve the grounds within or surrounding a structure or a tract or plot of land..."

You may want to refer the Insurance Company to the CSLB web site, which has a "Building Official Information Guide". One FAQ is "Can a landscaping contractor build a perimeter wall? The answer is they may, "only if the perimeter wall is part of a total landscaping project."

Further, in the Board's publication, "Hiring the Right Landscaper", one of the listed "Common Landscape Projects requiring a contractor's license" is fencing. Of course, a "C-13" contractor can perform this work; however, as in your case, this is one instance when more than one classification can be suitable for a particular project.

Q: We are a demolition contractor and we frequently do asbestos abatement. We have the asbestos certification on our license and we are also registered with DOSH. I see that the CSLB now has a "C-22" Asbestos Abatement classification. Are we required to add that to our license in order to continue providing the asbestos abatement services? Will I need to take an exam?



A: The "C-22" classification is not a replacement for the asbestos certification, which still continues to exist. The asbestos certification that you currently have allows you to perform asbestos abatement work in the trade(s) in which you are licensed and as allowed by your DOSH registration. The "C-22" is required if you plan to expand the scope of your asbestos abatement beyond work associated with your demolition classification.

As with all other classifications, the "C-22" requires that you document at least four years of full time journeymen (or above) experience, within the last ten, performing asbestos abatement work. A trade exam is also required. You may be granted a Waiver of the exam if you have held the asbestos certification, active and in good standing, for at least four years within the last ten. In order to qualify for the waiver you must have also been registered with DOSH for that period of time.

Q: I currently have a construction company with two other Partners, one of them being my husband. The third Partner is retiring. My husband and I would like to keep the business and the license in place but just re-structure the Partnership and change the business name. How do I go about notifying the CSLB of the change?

A: Unfortunately when a General Partner leaves the Partnership, the license must be canceled. You will be required to apply for a new license for the new structure of your entity. If you use the same Qualifier, he/she would not be required to re-take the exams. Please contact us if you'd like assistance with the process.

# Are you covering the cost of your Employee's Individual Medical Policy?

#### **Caution for Individual Policy Reimbursement**

The IRS uses a FAQ on Employer Health Care Arrangements to highlight the potential liability for employers that, rather than establishing a group health plan, merely reimburse employees for the cost of their individual health plan premium.

Q1. What are the consequences to the employer if the employer does not establish a health insurance plan for its own employees, but reimburses those employees for premiums they pay for health insurance (either through a qualified health plan in the Marketplace or outside the Marketplace)?

The IRS makes it clear that the consequence is that the employer may face a penalty.

Specifically, as explained in **Notice 2013-54**, employer reimbursement plans are considered to be group health plans and therefore subject to the market reforms, including the prohibition on annual limits for essential health benefits and the requirement to provide certain preventive care without cost sharing. Notice 2013-54 clarifies, however, that employer reimbursement plans cannot be integrated with individual policies to satisfy the market reforms.

Consequently, the employer may be subject to a \$100/day excise tax per applicable employee (which is \$36,500 per year, per employee) under **Code Sec. 4980 D**.

For plan years beginning on and after January 1, 2014, employers should carefully evaluate arrangements under which they reimburse employees for premiums, or are otherwise involved in the purchase of individual health insurance policies that provide non-excepted medical coverage (i.e., coverage that is subject to health care reform's mandates) for employees. These arrangements create significant compliance concerns under health care reform. Furthermore, these individual policies should not be paid for or reimbursed on a pre-tax basis under an employer's cafeteria plan. As described in more detail (left).



# Safety Tip of the Week

#### SAVE YOUR HANDS

Here's a test to see how fast you can untie your shoes. You can use both hands, but you can't use your thumbs. Not so easy, is it? And, yet, do you realize that 25% of all disabling injuries involve hands and fingers?

#### COMMON CAUSES OF HAND INJURIES

What are some of the common causes of injuries to hands and fingers, most of which usually are preventable? They include struck by hammers, pinched between objects being moved, cut by sharp objects, pierced by splinters and slivers, burned by hot objects or chemicals, and caught in moving machinery.

#### **GLOVES- A PRIME MEANS OF PROTECTION**

As long as your skin remains unbroken, it can keep germs out. Once it's opened by a scrape or cut, however, germs can get in and infection can result unless you get proper treatment. And, no matter how rugged you think your hands may be, they aren't tough enough to stop splinters, slivers, or to resist punctures. That's why gloves are important. They're like an extra layer of skin. The nail that rips your glove would have injured you if your hand had been bare. Wear gloves whenever you are handling rough or sharp material. Use rubber gloves when working with chemicals, solvents, or other material that can irritate your skin. Wear gloves that fit properly. Also, remember that gloves shouldn't be worn when there is a possibility they can get caught in moving machinery.

#### **GUARDS ARE HAND SAVERS**

Guards on power saws and other equipment sometimes seem like a nuisance, always getting in the way. But they're on the equipment to protect you against injury. By removing guards or otherwise making them ineffective, you increase your chances of getting hurt. Tie one hand behind your back for a day and you'll appreciate what the consequences of working without a guard can be.

#### OTHER DANGERS

Many hand injuries occur even when you are wearing gloves or using guards. Be alert to these dangers, too. Such injuries can result from the unexpected shifting of material, getting hands caught in pinch points, grabbing moving parts of the machinery, or holding work in the hands that should be held in a vise or securely clamped.
