Take Heed on Family Business Succession Before It's Too Late

We recently came upon a tragic situation that serves as a valuable lesson to all construction businesses regardless of your size. Did you know that if you're in a partnership and the general partner dies, the partnership (and contractor's license) ceases immediately? We have a contractor client where the father was the general partner for over forty years with his son listed as the other partner. Even though the son is obviously qualified, he is being required to apply for a new license and take both the trade and law exams, because the license ceased along when his father passed!

If the company was a sole ownership, the son could have applied for the family waiver through the following provision in the Business and Professions Code (assuming he met all of these requirements):

B&P 7065.1 (b) The qualifying individual is an immediate member of the family of a licensee whose individual license was active and in good standing for five of the seven years immediately preceding the application for licensure, and the qualifying individual is able to show all of the following:

- (1) The qualifying individual has been actively engaged in the licensee's business for five of the seven years immediately preceding the application for licensure.
- (2) The license is required to continue the existing family business in the event of the absence or death of the licensee.
- (3) An application is made for a new license in the same classifications in which the licensee is or was licensed.

For a corporation or LLC, the wavier requirements are as follows:

- (c) The qualifying individual is an employee of a corporation or a limited liability company seeking to replace its former qualifying individual and has been employed by that corporation or limited liability company under the following conditions:
- (1) For five of the seven years immediately preceding the application for licensure, the qualifying individual has been continually employed by the corporation or limited liability company in a supervisory capacity in the same classifications being applied for.
 - (2) For five of the seven years immediately preceding the application for licensure, the corporation or limited liability company has held an active license in good standing in the same classifications being applied for.

This goes back to our caution of several weeks ago – despite the fact that we all want to live forever, if you have concerns about the succession of your family business, make plans, NOW. Call us to be sure your business is covered for the unexpected!

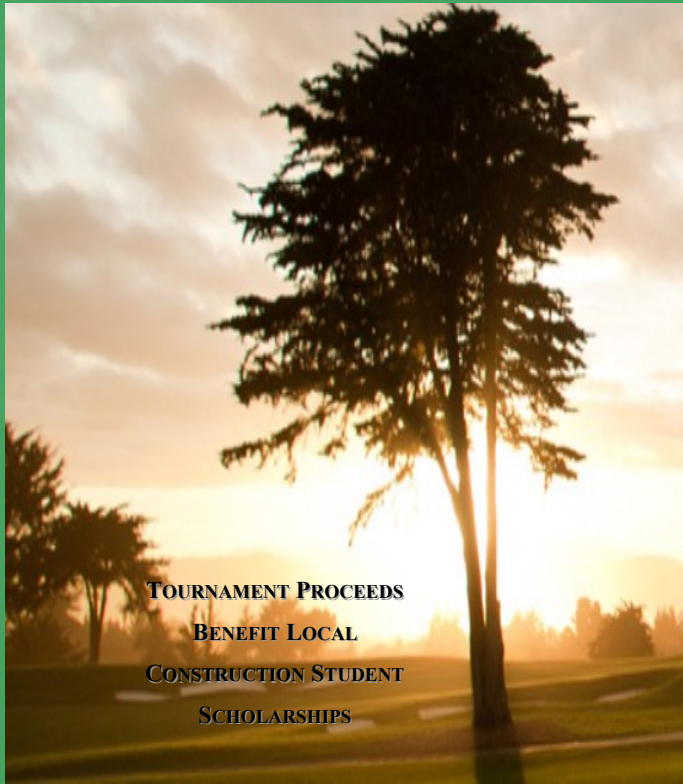

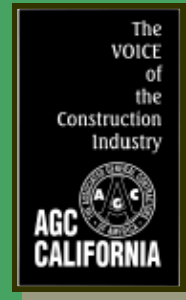

Baseball season is back and we go to bat today for an Arizona company, a veteran glazer and a plumber who pitches a 'wet' one. Unfortunately, by the end of the 'game' played here, readers will discover it's three strikes and you're out!..

Q: I have been a "C-17" (Glazing) contractor for many years. I recently took a position with a company that currently has a "B" (General Building) license. They want me to add the "C-17" classification to their license, which I plan to do, but they also want me to replace their "B" Qualifier. With respect to the four year experience requirement, does work done under a "C-17" qualify for General Building experience? My projects involve much more than just glazing. Within glazing falls coordination of structural steel, concrete, finishes, even landscaping.

A: You are going to have a hard time proving "B" experience working as a

"C-17". Sometimes people can claim work experience gained from a particular classification to qualify for another classification, but only if the classification is closely related. Glazing is more of a "stand alone" specialty classification that would be difficult to verify that you were performing the duties required to qualify for a General Building license. The CSLB will likely request that you show proof of your "B" work with contracts or permits showing that you performed specific trades such as framing, carpentry, plumbing, roofing, etc. so it seems unlikely as 'pitched'.

Q: We understand that a vehicle can be deemed "advertisement" and as such the vehicle should include the name under which our license is held in Arizona, as well as our license number preceded by "ROC". Our question is, do we have to include our full name or just the DBA (doing business as)? Such as AB Insulation Group Inc., d/b/a AB Insulation or just AB Insulation? Also, can we include the name of our Parent Company on the truck? For example "AB Insulation, a part of the AB Construction Services group of companies"?

A: You are correct that Arizona requires that your advertisements include your license number, including "ROC" preceding the license number, and your business name under which you are licensed. That being said, you would need to include the full name, AB Insulation Group Inc. dba AB Insulation, since that is the business name under which you are licensed. I did not find anywhere in the law where it states that you cannot include a Parent Company's name on the truck, but according to staff I spoke with at the ROC, you cannot include other business names on vehicles, only the business name on the license. This 'strikes out' any but the licensed name being used.

Q: Hi, I have a "C-36" license and I was told by the CSLB that I cannot work on swamp coolers. We have done this since 1960, and while it's not a major part of our business, it's very irritating that I'm being told we can't do it. It involves water supply, pump, and other "water" related parts and in my opinion should be included in the "C-36" (Plumbing) classification. How to I petition this and/or get a ruling?

A: I understand your thinking with regards to the "water" related parts, however replacing or repairing swamp coolers would not be covered under your "C-36". Depending on the scope of what exactly you're doing, it could be the "C-20" (HVAC), or the "D-34" (Prefabricated Equipment), or even a license with the Bureau of Electronics and Appliance Repair. So, as Mike Krukow says on Giant's broadcasts, 'grab some pine meat' you are out. And so are we!

Are you covering the cost of your Employee's Individual Medical Policy?

Caution for Individual Policy Reimbursement

The IRS uses a FAQ on Employer Health Care Arrangements to highlight the potential liability for employers that, rather than establishing a group health plan, merely reimburse employees for the cost of their individual health plan premium.

Q1. What are the consequences to the employer if the employer does not establish a health insurance plan for its own employees, but reimburses those employees for premiums they pay for health insurance (either through a qualified health plan in the Marketplace or outside the Marketplace)?

The IRS makes it clear that the consequence is that the employer may face a penalty.

Specifically, as explained in [Notice 2013-54](#), employer reimbursement plans are considered to be group health plans and therefore subject to the market reforms, including the prohibition on annual limits for essential health benefits and the requirement to provide certain preventive care without cost sharing. Notice 2013-54 clarifies, however, that employer reimbursement plans cannot be integrated with individual policies to satisfy the market reforms.

Consequently, the employer may be subject to a \$100/day excise tax per applicable employee (which is \$36,500 per year, per employee) under [Code Sec. 4980 D](#).

For plan years beginning on and after January 1, 2014, employers should carefully evaluate arrangements under which they reimburse employees for premiums, or are otherwise involved in the purchase of individual health insurance policies that provide non-excepted medical coverage (i.e., coverage that is subject to health care reform's mandates) for employees. These arrangements create significant compliance concerns under health care reform. Furthermore, these individual policies should not be paid for or reimbursed on a pre-tax basis under an employer's cafeteria plan. As described in more detail (left).

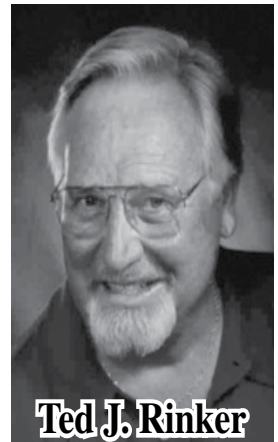

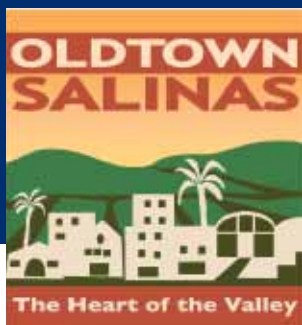

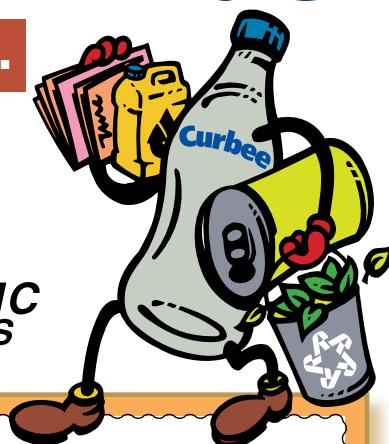

Safety Tip of the Week

EYE SAFETY

Some 150,000 disabling eye injuries occur each year. Eye injuries can occur in any operation and in any work area, including offices. All too often we take our eyesight for granted and figure that we'll always have it. We treat our eyes as though we can get replacements. How many home runs could Hank Aaron have hit if he had lost the sight in one or both of his eyes? How well would you be able to do your job if you were blind? There are two important issues to consider; first, you need to have the proper eye protection, second, you need to USE IT!

People who wear glasses usually become so accustomed to them that without much thought they clean them, carry them in their pocket or purse so they are handy, and wear them when they are needed. Unfortunately, few of us are this mindful when it comes to eye protection, and too often we forget it. Some safety glasses and goggles grow dusty from lack of use as their owners trust luck to protect them from an eye injury.

The most common complaint about eye protection is that it's uncomfortable. Protective eye equipment must be carefully fitted and then worn correctly. It may take some time to adjust to wearing goggles or safety glasses, but it will take much longer to adjust to losing your eyesight. If your goggles or glasses give you a headache, adjust the frames or straps or consider a new pair. Straps used to hold goggles or glasses in place should be adjusted to provide just enough tension to hold them securely. During hot weather, a sweatband will keep perspiration off your goggles or glasses and out of your eyes. Take time to clean your goggles or glasses so they do not interfere with your vision. Don't touch the lenses with your fingers, and keep them away from anything that could scratch or pit them.

Protective eye protection extends beyond keeping bits of debris out of your eyes. If you are working around welding or cutting operations special lenses may be required to protect your eyes from the bright, intense light. Chemicals also pose a hazard to your eyes; make sure you use eye protection and splash guards when handling chemicals.

Your employer will provide eye and face protection when machines or operations present the potential for eye or face injury. See 29 CFR 1926.102 for more information and a selection guide for proper eye protection.

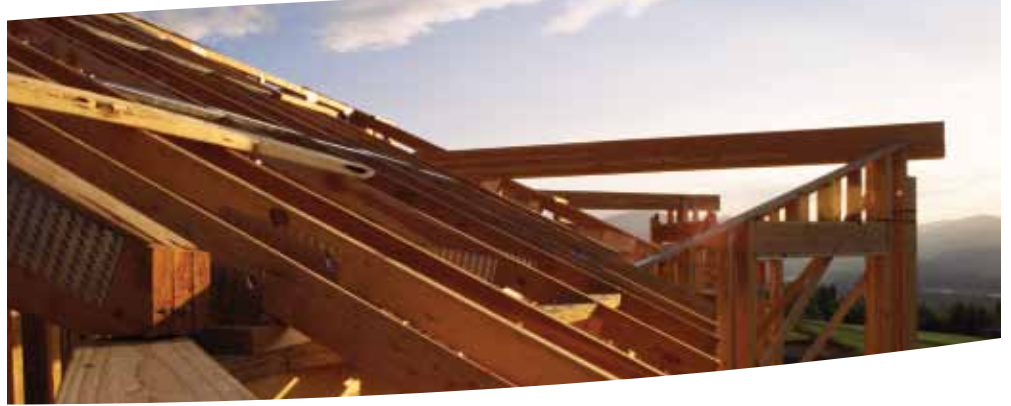

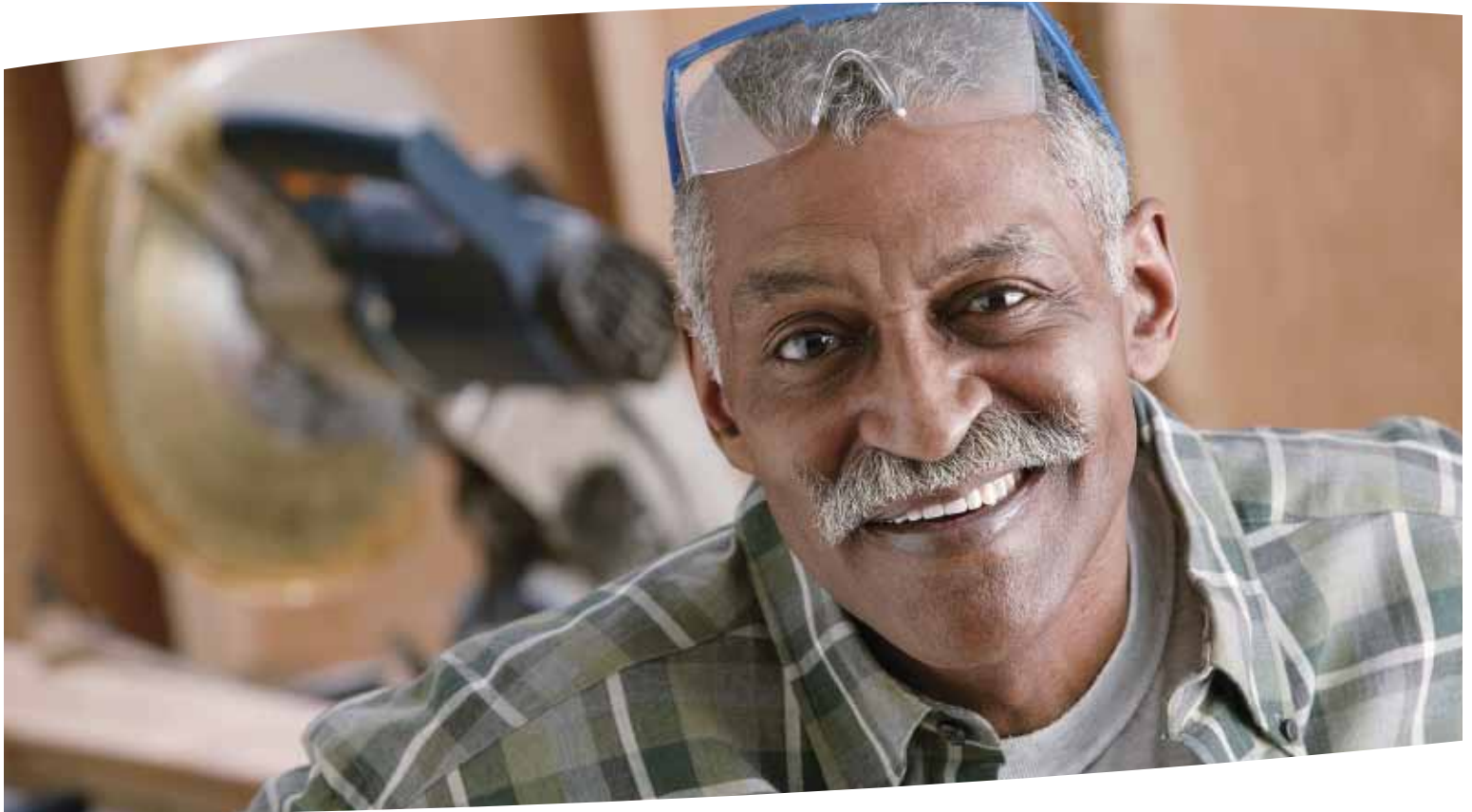
