BUSINESS UPDATES



California on Brink of Further Expansion of Fair Pay Protections

California's legislature is close to passing three bills to expand the state's fair pay laws. The bills, introduced in early 2017, were designed to expand upon, or clarify, the amended California Fair Pay Act (CFPA).

The bills include:

- Assembly Bill (AB) 1209: To require employers with at least 500 employees in California to collect and submit information to the California Secretary of State regarding: (1) the difference between the median and mean salaries of male and female employees located in California who are exempt under the white collar exemptions; and (2) the difference between the median and mean wages of male and female board members who are located in California. The Secretary of State will publish this information on a publicly available website.
- AB 168: To prohibit employers from seeking salary history from job applicants.
- AB 46: To amend the CFPA to clarify that its provisions apply to both public and private employers.

While all three bills are moving toward adoption, AB 1209 is the closest.

AB 1209

As of September 11, 2017, an amended version of AB 1209 had passed both the Assembly and the Senate over the written objections of groups representing employers. AB 1209 has been amended as follows:

- To provide that wage differentials between men and women are not presumed violations of the CFPA or limit an employer's ability to demonstrate a basis for the wage differential.
- To require employers to update and republish information biennially on July 1 (as opposed to annually, as provided in the original bill).
- To provide that the collection of this information is limited to employees and board members located in California (there was no geographic limitation in the original bill).

Governor Jerry Brown has until October 15, 2017, to sign or veto the bill.

AB 168

AB 168 was passed by the Senate on September 12, 2017, and the Assembly is considering the bill. The bill prohibits employers from seeking job applicants' salary history. On September 8, 2017, the bill was amended to provide that:

- 1. An employer may not rely upon the salary history information of an applicant (unless it is disclosed voluntarily and "without prompting");
- 2. Applicants may voluntarily "and without prompting" disclose salary history information to a prospective employer; and
- 3. Nothing in the bill shall be construed to allow prior salary, by itself, to justify any disparity in compensation.

AB 46

On September 12, 2017, AB 46 was ordered unanimously approved by a Senate Appropriations Committee and is pending before the legislature. The bill has not been amended since its introduction.

* * *

California already had strong fair pay laws. With the passage of these amendments, employers must be proactive in examining and fixing their pay practices to ensure compliance.





Whenever you visit a 'foreign' place like CA, it's good to get a guide! Let me point the way. Assisting contractors would be 'dbaa' for Capitol Services, or doing business as always, for some with 'unacceptable' business names a 'dba' is the way...

Q: We recently applied for a California Contractor's License. We have licenses in several other States including Florida, Nevada, Washington, and Arizona. We applied under our corporate name which is the President's last name followed by "Commercial Contracting Services". The CSLB rejected our application stating we cannot use "Contracting Services" in our business name. This is how we are licensed in all other States. We are already registered with the CA Secretary of State with this name. What do we do? The rejection letter didn't give us much guidance.

A: The CSLB's guideline is your business name must either identify the trade classification you hold, or be a completely fictitious name that has no meaning. In addition, you cannot use vague terms in your business name such as "services", "improvements", "contractor", or "solutions". "Contracting Services" is considered a vague term. You will need to either change your name with the Secretary of State, or come up with a 'dba' (doing business as) name to add to the license application.

Q: We are a General Engineering contractor and our range of services include site engineering, industrial and wastewater treatment, water utility and technical services, water conditioning, water purification systems, and laboratory services. We recently formed an LLC to take over the operations of our currently licensed Corporation. Our application was rejected due to our business name not being "compatible." The letter instructed us to come up with a few 'dba' (doing business as) names and submit them for review, which we did, and the CSLB responded by saying none of the names were acceptable. Can you give us any direction?



A: After reviewing your submission, I see the issue is each Business name you presented included the word "water". The CSLB has been strongly implementing B&P Code Section 7059.1(a) which states "A licensee shall not use any business name that indicates the licensee is qualified to perform work in classifications other than those issued for that license, or any business name that is incompatible with the type of business entity licensed." While you do need an "A" (General Engineering) license to perform the work you do, using the word "water" in your business name could imply that you are a swimming pool Contractor. I suggest you come up with a business name without the word "water", or somehow incorporate "engineering" in the business name.

Q: We have a license that holds the "B" (General Building), "C-10" (Electrical), and "C-36" (Plumbing) classifications. Our Qualifier left the company and we only have until the 15th of next month to replace him. We have employees who hold the Electrical and the Plumbing licenses (Inactive) who are willing to be added to our license. What will happen to the "B" classification if we don't have someone to replace in time?

A: If you do not replace the Qualifying Individual for the "B" classification within 90 days of his disassociation date, the classification will be removed from your license. If you find someone and submit the application prior to the 90-day cut off, you can request a onetime 90 day extension to allow for processing time and testing if needed.





Safety Tip of the Week

PERMITS

Permits are needed in construction because certain work conditions present hazards during particular activities. These activities must be evaluated and determined to be safe prior to any work taking place. There are various types of permits. A typical group that may be found in construction include -- excavation permits, hot work permits, confined space permits, personnel basket permits, lockout-tag out permits, electrical hot work permits, line break permits, crane permits, heavy/critical lift permits, and there may be others required on you r worksite.

There are some general rules to abide by when using permits. First, always inspect the area you are about to work in. Identify fire watches and fire extinguisher locations. Insist that all required signatures are obtained prior to starting work. Look for obvious hazards. Review emergency procedures with all crew members. Make sure all workers are wearing the required personal protective equipment. Inspect your hand tools and check other equipment you may need to use. Follow all visual signs and instructions. Be prepared for the unexpected. Don't take any chances. Your life and others that work in the area will depend on each member of the crew doing the job correctly. If your permit requires testing, be sure to have the testing done prior to entry.

Lock, tag, and try procedures are a must when preparing for a plant shutdown, equipment shutdown, equipment isolation, or release and control of stored energy. Watch for pinch points when you are blocking lines and closing valves. A permit is usually issued for a specific amount of time, typically one shift. At the end of the shift the permit becomes void or invalid and must be reissued. See your supervisor about who to contact to get a permit reissued. A permit is a document allowing you to do something that involves a hazard of some kind. Follow it to the letter. Permits enable us to have safer working environments. Misuse may cause an accident and possibly a death. No one wants that!
